The School shall admit in class I, to the extent of 25 % of the strength ofthat class, children belonging to weaker section and disadvantaged group inthe neighborhood and provide free and compulsory elementary education tillits completion. Provided, further that in case of pre primary classes also, this norm shall be followed.

For the children referred to in paragraph 3, the School shall be reimbursed as per 4. Section 12(2) of the Act. To receive such reimbursements school shall provide a separate bank account.

The Society/School shall not collect any capitation fee and subject the child or his 5.
